88/2019 ESCC report

There is a new Highways Liason Officer, Corinne Black and can be contacted at corinne.black@sussexhighways.com and the title has altered to Customer Services Manager. County Cllr Davies had no further updates to her report previously distributed.

89/2019 Public Questions:

(a) National Trust, Fencing and Signage

Mr Nick Gilbert stated that like many local residents who had lived here for some years, he felt that the National Trust had done nothing for the betterment of the Village. When he first moved into Bodiam 22 years ago the Villagers could walk the grounds for free. He went on to explain that if a walker wishes to walk south from the East Sussex Border Path then east along the north bank of the river, there is now a fence blocking the route with a large locked iron gate. Mr Gilbert felt that this was there to collect more revenue for the NT and questioned whether this was necessary. Mr Gilbert feels that it had already been established as a right of way for many years and that the actions of the NT had only stopped this recently by installing the gate. He requested that the Parish Council get in touch with RDC and ESCC to have the padlock on the gate removed, as this was the agreement in which the gate was installed. (At present this is not a recognised footpath.)

Mr Gilbert also questioned the decision of planning permission granted by RDC to turn the field by the river into a car park, as walkers and cars could be on a collision course. Answering these points with regard to the gated path the Council advised that

- 1. There were forms obtainable from the ESCC to make the path a right of way.
- 2. The National trust had been careful in the decision of to remove parking from the ancient monument and to get traffic off the road. This will be a replacement car park to cope with surplus parking on busy days and it is the only place for it to be.
- 3. With regards to the revenue from Bodiam Castle In recent years visitor numbers have fallen at Bodiam.
- 4. It was suggested that inviting the National Trust to an open meeting to answer some of these questions. Clerk to write to the NT to arrange an open meeting possibly on site in the Evening over the next couple of months to discuss these matters to update us on the Sewerage situation and ask for access to financial records.
- 5. Chloe Rowling from the Rights of Way Office has been around the site and all the fencing and signage is legal.

(b) New Bodiam Football Team

Mr Nathan Goodsell introduced his son, Will Goodsell who is hoping to set up a local football team, and were hoping that as Bodiam did not have a local team already that they would be able to use the Recreation Ground for their home games. Cllr Mitchell explained that they would have to hire the Recreation Ground and Pavillion on a game or season basis. Sedlescombe Rangers have been using the Ground for some of their matches last season, so they would have to be approached and asked if they could work around each other games. Bodiam would probably require the use of the pitch on a

Saturday afternoon. Will enquired about Goal Posts, Nets, Line Marker Machines and Grass Mowing.

Mr Goodsell enquired if being a local team the Club would have to pay any fees. Cllr Mitchell explained that there would be a charge and the fee would be discussed at a Council Meeting if the team were to go ahead, and that the Council could give a discount if they booked for a season rather than paying by the match.

Cllr Peters informed the Goodsells that they may be able to get a set up grant from the Sussex Community Foundation who help with local sports clubs.

Cllr Mitchell to contact Sedlescombe Rangers and Clerk to contact The Goodsells with the outcome.
