34/2022 Councillors Meetings with Outside Bodies

Cllr Stevens had an informative meeting with Karen Stafford the manager of Bodiam Castle last week.

The Council have been offered the Wharf Tea Room to host the Parish Assembly and would also be happy to line up a tour of the castle and a talk from Lucy the ranger.

Some further work has been completed regarding the sewage problem on the manhole covers and there is an additional clean of the treatment plant needed. They are also still discussing the pub fat trap with Shepherd Neame.

They are looking at having a more permanent visitor centre where the current temporary one is and a replacement 'workshop/shed area' where the current 'bonfire' area is by the back gate so the metal containers can be removed.

Conservation work on the postern tower is to carried out later this year (the timing of which is largely dictated by the bats!).

The National Trust are also keen to publicise the second hand book store and some children's colouring activities have been offered for the jubilee event and we may also have access to a marquee (the castle is not currently planning to do anything specific for that weekend).

They are looking at how to 'manage' the paddle-boarding activity along the river as they own some of the river bank and as a result have the H&S issues to consider. They have also had

The Council tax has thought has been confirmed as a 1.99% increase this year.

Community matched funding has built up a surplus over the years as not enough communities could raise the 50% matching. Yesterday the decision was taken to release most of this totalling £750k for road safety projects which do not need matching. The procedures for this are still being set out but a key aim is that the criteria are less KSI/accidents but more community demand.
