ESCC Confirmation at County of 41-million-pound grant from the Government towards transport, hopefully some which will be diverted to rural areas in particular DDRT (Digital demand-responsive transport) to provide a public transport service in areas of low passenger demand where a regular bus service is not considered to be financially viable, such as rural areas. Services may also be provided for particular types of passengers.

Councillors have received the previously circulated report from RDC. Full report can be read on the Bodiam Website.

Cllr Ganley advised that there is a planning application in Sedlescombe RR/2022/840/P, which could have significant impacts on all our parishes if it is not rescinded. Several Parish Councils have raised their concerns about this site in the AONB. Councillors have expressed their strong concerns over the precedence and there were 5 reasons for refusal. The committees vote hinged on NPPF para 8 (e) which states any new build in the AONB should be architecturally outstanding. This house is an off the shelf kit house which although it is carbon neutral is not an outstanding design. It is now with the Secretary of State for a decision. Bodiam Parish Council will submit comment and issue objection to the Secretary of State.
