38/2023 Rural Grass Cutting-

For 2023 East Sussex County Council (ESCC) is offering all Parish and Town Councils the option of reduced rural cuts to aid biodiversity. This is being done as an extension to an ongoing trial that took place in 2021 and 2022.

The reduced rural cutting service reduces the frequency of grass cutting services along rural verges to visibility cuts only to be undertaken around May/June and a one metre swathe with visibility cuts in the Autumn.
