This ESCC service is a cross between a taxi which takes one customer from one chosen place to another at a chosen time, and a scheduled bus service which runs at scheduled times from between bus stops. Flexibus runs from a meeting point, which is likely to be close to your home or other start location, to another and often picking up other passengers on the way.

More money is going to made available for road maintenance.

115/2023 Recreation Ground

(a) Pavilion, Upkeep, and Inspection – made this evening by Councillors

The Pavilion was cleaned thoroughly before the School Sports day on Wednesday and the Funday last Saturday with pressure washers etc. The building is not in good shape and even with a thorough clean still looks shoddy and complaints were made regarding its condition. The question is whether it is still in a passable state to hire out. The Pavilion floods every winter and the cupboards and walls have to be pressured washed.

We have one regular user of the pavilion which provides some income to pay the electric and water bill, and Sedlescombe Rangers may use the field for the juniors over the summer period.

There is no disabled access to the Pavilion, and because of the flooding can only be open 6 months of the year.

It was proposed the Council need to decide what to do with the Pavilion, to put a survey with details and photos with costing together, and put before the residents.

There could be a few options;

- (a) demolish and clear the site completely,
- (b) demolish and leave the base for a bandstand, an area to sit in if it rains,
- (c) or rebuild smaller, a small kitchen area and toilets in a drier position with disabled access.
