149/2023 ESCC Report

Councillors had received the previously circulated report from ESCC and the full report can be read on the Bodiam Website.

ESCC Cllr Redstone has met with the Operations Director for South East Water. SEW have appointed someone to be responsible for water bottle distribution. The water stations must be manned with trained personnel; this has been done in the past by office staff from SEW. It has been suggested that Parish Councils could organise a rota for this and a training video is available. From a meeting with SEW in June it was clear that the configuration of mains supplies does not have natural resilience, and ESCC Cllr Redstone will try to find out how much excess water *delivery* capacity we have.

Highways have reported that in the next 28 days the remaining unfilled potholes in Bodiam are due to be repaired, and the subsidence outside Bodiam School is still under investigation.

157/2023 National Trust- Water Easement Bill

The Parish Council have received a bill from the National Trust for waterpipe easement (sewerage from the pavilion, goes into their main sewage drain). The bill goes back to 14th May 2018. When the Council enquired why this had not been sent out before the Clerk was informed that the charges were not added to the system and hence, no invoice was raised. The National Trust have now updated their system to raise these annually.

After discussion, Council recommended replying to the National Trust offering an immediate payment of half of the bill in full and final payment.

158/2023 Recreation Ground

(a) Pavilion, Upkeep, and Inspection

The last inspection was made after the Pavilion had been vandalised and boarded up. There are no immediate bookings and as it is unusable and will flood again over winter it will not be rented out.

EDF have contacted the Clerk, wishing to install a smart meter at the Pavilion, clerk to ring and explain circumstances, that it may not be worth converting. The future of the Pavilion is still under discussion.
