Proceedings and reports of committees and working parties

- **Recreation Ground:** four quotes had been received for the removal of the boat and two for its repair and for further repairs to the recreation ground equipment. After some discussion is was suggested that Safeplay Spaces should be asked to repair the boat, replace the swing shackles, lay new rubber matting under the swings and adjust the giro spinner to make it safe. There should then be another independent health and safety inspection done to ensure all is now up to standard.
- **Village Hall:** New Chairman and Vice Chairman appointed at the last meeting.
- **285 Footpaths:** No report.

Cllr Armstrong now has the definitive maps of the parish footpaths and also the maps from the 1930's. Cllr Oliver asked if the landowner of the footpath on Broadlands Row could be contacted and asked if some suitable gates might be installed. Cllr Oliver will see if the landowner will give permission to take this further.

- **Seats, trees, bus shelters and bins:** No report
- **Community Hall:** Cllr Nottage has now changed the locks and the Hall has been cleaned and tidied. A deposit for the keys will now be required from all hirers (£50). To start looking for funding grants.

- **289 Police Report:** No report
- **290** Newsletter: Ready to go out.
- **Resilience Planning:** Basically it is prepared but the difficulty is now finding the volunteers to put their names down to help. There is a need to identify possible helpers and write to them asking if they are prepared to help, medical people, farmers etc.
- **Website:** The clerk has looked at which other councils use the Rother hosts and those using an alternative host. Councillors were asked to look at Crowhurst, Udimore, Bodiam and Peasmarsh, who all use Rother and then Battle and Whatlington who use Hugo fox and bring their thoughts and findings to the next meeting.

Speed Watch: The police were present in Broad Oak three weeks ago and issued 5 tickets. 66 cars were caught speeding in the last month, making 1403 in the rolling year.

Items for discussion

- 294 Dog Bins There had been a request come in through the website about an extra dog bin on Broad Oak. Current dog bins are not outside residential properties. The suggested new sites would be right outside someone's front door, which was felt to be unacceptable. After discussion it was felt there were no suitable sites away from residential areas. (Prior to the new contract starting Rother were not taking on any more bin emptying, so that will need to be checked before installing new bins.)
- **Bus Shelters** As the previous contractor had now contacted the clerk to say he could not do the work, two more quotes had been obtained. Cllr Armstrong proposed that the quote from LW construction was accepted. Cllr Oliver seconded. All present were in favour.
- **Boat on the recreation Ground** Following the earlier discussion under matters arising, the work discussed was proposed by Cllr Nottage and Seconded by Cllr Oliver. The majority were in favour.
- **Parish Assembly 2020** Cllr Apps was asked to prepare the signs. The police have been contacted and will be present. The presentation will be first, followed by refreshments, then the council report, the police the District and County Councillors and finally the awards. It was suggested that the awards be presented by the previous year winners.
