Purchase of two Royal British Legion Tommys. (Agenda item requested by Cllr Allison)

Proposal, to purchase two Royal British Legions Tommy statues for the Parish, one to be sited on the Village Green near St Georges Church in Brede, the other at a site to be identified in Broad Oak, possibly the corner of the crossroads on the grass verge.

(Note: The land will need to be owned by the Parish Council or we need permission to site them. They must also not be close to the Highway, or a licence may be required to out them up, or a registered person to install them.)

Costs. Two standard Tommy Statues £175 each (if purchased as a pair, one facing each way there is no additional shipping charges). Total cost £350.00

Plus costs for Handy man to fix in place.

Tommy Statue £175 plus shipping Can be installed in the ground using included angle irons, or mounted on the side of a wall or building using wall plugs and fixing screws (not included.) Pack includes - 1 x Unknown Tommy Statue - 1 x 6ft 30mm face Angle Iron - 1 x 3ft 30mm face Angle Iron - 5 x Locking nuts & bolts - 5 x Washers & bolt caps
Tommy for Lampost £225 plus shipping Can be securely fixed on lamp posts using the included channel clamps. Pack includes - 1 x Unknown Tommy Statue - 3 x 76mm sign clips, 3 x nuts, bolts and washers - 3 x 89mm sign clips, 3 x nuts, bolts and washers

Rother District Council Public Spaces Protection Order Review

Rother District Council is reviewing its public space protection order for Rother. The order allows the Police and council staff to issue on the spot fine for defined types of anti-social behaviour if they are a particular concern for the community. Earlier in the year we asked parish and town councils for information related to the review. All responses were reported to our Cabinet.

We wish to invite Brede Parish Council to give any further views on the current order and if it needs any additions. This is because anti-social behaviour in public spaces might affect the activities of the council, businesses and residents. Secondly, it is later in the year with a more normal return to work and schools. Thirdly, we have some possible additions we would like the council to consider.
