Dark Skies Accreditation -

Letter from David Field representing 6 parishes sent to High Weald Joint Advisory Committee asking for their support.

To do: Brightling lighting policy required – stating that although we do not presently have street lighting if in the future we were to acquire some it would align with the High Weald National Landscape (HWNL) Management Plan 2024-29 under policies D1 and D2 and with the HWNL Dark Skies Technical Advice Notice.

Rare Bees Resilience

Expression of interest for Park View land to be considered has gone to Michelle Pletsch of GroundWork South who is planning the project for Rother. She will decide if the area is suitable for particular bee species. If it is then an application needs to be made early 2026 and a management plan created.

There is money available for capital funding – contractors, fencing, plants etc but not for doing the actual work and it needs to be volunteer led. Expectation is for it to run for 10 years plus. The land would not be restricted for that single use, although other activity should not impact on the habitat. BEG have expressed interest.

It should help focus any action we might take or encourage residents to take to relevant projects. Large areas in Brightling have been highlighted as of particular importance for biodiversity and the creation of new habitats, these include gill woodland, wood pasture and

parkland. We should check if other parish councils adjacent to us are planning projects – it makes sense to coodinate and collaborate.

The Rare Bees resilience project would also directly support the Sussex Local Nature Recovery strategy and Natural England's Threatened Species Recovery Actions.
