Minutes of the meeting held in Hurst Green Village Hall on Tuesday 24th September 2019 starting at 8:05pm.

2.0 MINUTES OF THE LAST MEETING: -

Councillor Janes declared an interest in agenda item 8.3 the Breakfast Club as he helps to run it.

4.0 COMMUNITY- Activities and reports: -

The Chair moved agenda item 8.3 up the agenda due to the public interest in this item which had been discussed before the meeting in Parish consultation time.

8.3 Motion to continue to support the Breakfast Club (*Cllr. Browne*)

Councillor Browne proposed a motion to continue to support the Breakfast Club under s132 and this was seconded by Councillor Johnson.

There was much debate on this item in which Councillor Janes did not take part due to declaration of interest and did not vote.

Motion was passed by 6 to 1.

Councillor Brown gave the report and also answered questions from Councillors.

Grant money has or will shortly be rec'd of £2,493 for itemized spending and a further grant is being sort for Community Led Housing (affordable homes)

i) Review progress of call for more potential sites

Councillor Brown wished it to be known that potential new site applications would be welcome and this was still open to owners.

4.2 Community Shop report and position statement and to pass any resolutions proposed.

Councillor Janes gave the report and noted that the process of winding down the business was ongoing but expected to be finished soon.

4.3 May Bank Holiday celebrations, VE Day 75th anniversary (Cllr. Browne)

Councillor Browne reported that he would like the village to participate in this event, a view that was supported by the Council. To this end a working party was set up consisting of Councillors Browne, Hampton, Janes and Johnson.

4.4 <u>Clerk's report – circulated</u>

The Clerk was late circulating this by email and therefore handed out hard copies of the report No questions rec'd.

4.5 Parish Correspondence and local resident issues

Councillor Barnes reported on updates he had rec'd re Sweethayes Farm, dumping of soil which has ceased and soil dumping at Lime House Merriments Lane which is an ongoing investigation. Councillor Barnes was asked if any dumped soil was to be removed from Sweethayes due to the amount dumped. Councillor Barnes will look into this.

6.0 TRANSPORT, ROADS & FOOTPATHS

Councillor Johnson reported two water leaks in the road near the entrance to Great Oak and outside Lodge Field.

Councillor Barnes was asked to get an update re enforcement action on footpath 27 at The Stage. Councillor Browne reported that the illegal sign on the gate at Coopers Corner would be removed by the 3rd October.

Gutters along the A21 are blocked. Clerk to contact Aone+.

Councillor Brown reported on his A21 speeding data and that a scheme has been drawn up for the A21 from Lamberhurst to Hastings but it is very much only a drawing board exercise at the moment. Councillor Barnes suggested that a formal request be put to Huw Merriman to put a question to Parliament concerning the issue of the A21.

6.1 Community Speedwatch Initiative report

It was reported that Kent Police have different rules for Speedwatch than Sussex Police and different criteria. Speedwatch signs have now been printed.

6.2 <u>RDC - Introduction of civil parking enforcement and formal consultation on proposed changes to parking restrictions</u>

Although no direct changes in Hurst Green Councillor Barnes suggested that the Council should use this opportunity to ask for yellow lines to be looked into in relation to Station Road and in particular at the corner near the Village Hall. Clerk to respond.
