HURST GREEN PARISH COUNCIL

Minutes of the meeting held in Hurst Green Village Hall on Tuesday 30th January 2018 starting at 8:00pm.

Present:- Councillor Browne (Chair), Councillor Brown, Councillor Janes, Councillor Johnson, Councillor Wright and County Councillor Barnes.

The Clerk and the RFO, David Hilbourne were in attendance along with five members of the public.

1.0 Apologies for Absence: Councillor Duddridge (*ill health*), Councillor Peacock (*away*) and District Councillor Prochak (*attending another meeting*).

2.0 Minutes of the last meeting:-

To sign as a correct record the minutes of the meeting held on the 28th November 2017.

Minutes proposed by Councillor Janes and seconded by Councillor Brown.

The Chair read out an email from Trevor Leggo (SSALC) re necessary content of minutes and requested that in future minutes should only record the basic minimum legally required.

3.0 DECLARATION OF INTERESTS, in accordance with the Members' Code of Conduct: to receive any disclosure by Members of personal interests in matters on the agenda, the nature of any interest and whether the member regards the interest as prejudicial under the terms of the Code of Conduct

Councillor Janes declared an interest in agenda item 5.2 Hurst Green Magazine as editor and producer. Councillor Browne declared an interest in 6.2 Planning, applications RR/2018/10/P, RR/2018/2/P and RR/2017/2722/P as he knows the applicants.

Report given and decision to form a working party with Etchingham Parish Council to look at a joint solution to proving a service to local residents.

5.4 <u>Parish Council Website</u> - to receive a report from Councillor Brown on the ICO's model publication scheme compliance review (Freedom of Information Act 2000).

RR/2017/2555/P – Windmill Farm, Silverhill, Hurst Green. TN19 7QB. Single storey side extension and open canopy. New external steps. New roof to workshop and garage. **Granted.**

RR/2017/2666/O - Brook House, Ticehurst Road, Hurst Green TN19 7QT.Replacement of single storey rear projection with single storey extension. Granted.

RR/2018/2/P - 26A Station Road, Hurst Green TN19 7PL. Extension at first floor level to form maisonette. **Not supported** *due to privacy issues with neighbours*.

RR/2018/10/P - Bateups, Ticehurst Road, Hurst Green TN19 7QT. Demolition of existing outbuildings and new build annex. No comments. in Ticehurst Parish.

RR/2017/2722/P - Cygnet Fields Farm, London Road, Hurst Green TN19 7QR. Change of use of static caravan from mess facilities to temporary home for agricultural worker. (Retrospective). **Majority decision not to support**, *unnecessary dwelling outside development boundary*.

RR/2017/2564/MA - 1 London Road, Lodge Farm Cottage, Hurst Green TN19 7QP. Minor amendment to application RR/2017/1200/P to allow change of materials from timber windows to upvc, from black stained boarding to natural oak boarding, from plain clay tiles to natural slate. No objections, *no issues with this*. RR/2018/286/P - Hornbeam Cottage, Bugsell Mill Lane, Hurst Green TN19 7QJ. Proposed single storey side and two storey rear extensions and alterations. Supported.

9.2 Upkeep and maintenance of Parish controlled playing fields and public spaces

Correspondence has been rec'd from a resident expressing concern over the maintenance of Lodge Field and the removal (some years ago) of the cherry trees. To be looked into further.

10.0 Footpaths, Transport & Roads

Highways England have emailed re resurfacing sections of the A21 in early 2018 but the section through the village is not included despite the sections either side of the village (Swiftsden and Silverdale, Silverhill) are down to be done! Clerk will write and ask why the village is not being done as the potholes through the village are the worst part of the road surface in the area.

10.1 <u>Safety Improvements for Coopers Corner</u> - to receive a report from Councillor Brown and to consider the proposed recommendations

Councillor Brown gave his report and asked the Council to consider the three motions below:-

Motion 1: "That Hurst Green Parish Council is dismayed that the Coopers Corner junction at Hurst Green has been named by the Road Safety Foundation as the most dangerous place on the road network in the entire county and calls on East Sussex Highways, Highways England and bodies such as the Road Safety

Partnership to build relationships and work together along with the Parish Council, local MP's and with residents to urgently produce an actionable plan to assess and improve safety at this junction, for now and in the future, delivering on promises made to improve the personal injury collision record on the A21, ensuring that everyone gets to go home safely at the end of every day."

Motion 2: "That Hurst Green Parish Council continues to recognise the hugely negative impact the ever increasing through traffic carried on the A21, A265 and A229 has on residents' quality of life, with noise, inconvenience, pollution and recognises the devastating impact on people's lives that occurs when collisions and accidents happen. This council remains committed to lobbying the relevant parties for change that will see safety improvements and ultimately all through traffic removed from the village's roads to enable the village to become a safer place."

Motion 3: "That Hurst Green Parish Council are pleased that Highways England have responded to the repeated requests of this council to resurface the A21 through the parish with low noise tarmac in early 2018, but are dismayed at the decision to not include resurfacing the A21 though the village itself in its plans and calls on Highways England to reconsider its decision to not include the village in its 2018 resurfacing plans."

The Council unanimously resolved to pass the three motions above.

10.3 Feedback from meeting with Huw Merriman on the 12th January

Report given on a successful meeting.

Huw Merriman is now planning a meeting with the relevant minister in London to discuss the issue of the A21.

The RFO, David Hilbourne responded to this on the premise that the Council does not hold reserves as defined by the question although there are general allowances built into the budget for flexibility if needed.
