10.1 <u>Footpath 23 (off London Road by Jesses)</u>

A site meeting has taken place with the concerned parties and the minutes of the meeting were read out to the Council by Claire Barrett.

Councillor Browne said that he believed Councillor Barnes was dealing with this issue.

Still ongoing issues here for neighbours and the Clerk will check with ESCC into what steps were taken by them when a diversion was asked for. Clerk noted use of FOI Act.

10.2 Feedback from A21 meeting with Highways England and Huw Merriman MP

Francis McKenna took minutes of the meeting which have not yet been made available but Councillor Browne gave feedback

It is planned that the A21 will be used as a major pilot for the new average speed initiative which will involve a substantial increase in street furniture along the A21's route with extra cameras. The new system can be switched on and off as necessary but motorists will face penalty points if they are recorded as going over the prescribed speed limit over a given distance

It was noted that the new proposed extension to the speed limit to the north of the village was confusing as the papers are quoting 40mph whilst Councillor Browne is sure it is 50mph.
