# 5.2.1 Fete Report

#### 5.4 County/District Councillors Report

District Councillor Prochak noted that Rother District Council's Scrutiny Committee had altered slightly as it was now a combination of two previous committees and that there was now a new Chair. Residents are being encouraged to use the online application to report missed bin collections rather than phoning. There is now a new way to register for Voting with individual residents needing to register online. Fees are changing for planning applications with major developments having a fixed fee of £240 per sq. metre of which the Parishes should get 15% as a Community Infrastructure Levy.

Proposed change of use of ground floor of oasthouse with first floor in existing residential use to form one detached dwelling unit; also, alterations and extensions including reinstatement of roundel roofs, alterations and change of use of outbuilding to form incidental office and change of use of a cart lodge to form incidental garaging. **Granted**.

RR/2014/821/PWhite Horse Inn, Silverhill, Hurst Green TN19 7PU Change of use from public house to a single dwelling. **Granted**.

<u>RR/2014/822/L</u> White Horse Inn, Silverhill, Hurst Green TN19 7PUChange of use from public house to a single dwelling. **Granted**.

RR/2014/1248/O - Home Farm, Haremill Lane, Hurst Green TN19 7QJ Occupation of the property known as Home Farm in non-compliance of an agricultural occupancy condition for a period of more than 10 years. **Supported**.

RR/2014/1148/P - Grovehill Barn, London Road, Hurst Green TN19 7PS Proposed new access. **Supported**.

RR/2014/934/P - 1 & 2 Coleman Way, London Road, Hurst Green TN19 7PN Conversion of commercial units (1 and 2) to four flats (1  $\times$  1 bedroom and 3  $\times$  2 bedroom) using existing roads and access rescheduled parking and existing open space and refuse facilities. Supported but some concern at yet more loss of commercial premises.
