Extraordinary General Meeting

Minutes of the meeting held on Thursday 3rd October 2024 in Hurst Green Village Hall starting at 7.30pm.

Present:- Councillor Browne (Chair), Councillor Brown, Councillor Daly, Councillor French, Councillor Johnson-Cloves, Councillor Pakenham (from 7.35pm), Councillor Levine, Councillor Ralph, District Councillor Barnes and County Councillor Kirby-Green..
The Clerk was in attendance along with thirteen members of the public.

1.0 APOLOGIES, *to receive apologies and approve reasons for absence*
Councillor Price, absence approved.

2.0 DECLARATION OF INTERESTS - *in accordance with the Members' Code of Conduct: to receive any disclosure by Members of personal interests in matters on the agenda, the nature of any interest and whether the member regards the interest as prejudicial under the terms of the Code of Conduct.*

Councillor Pakenham arrived.

Councillors French and Brown introduced the motion and principally for the benefit of the members of the public present, outlined the changes present in the documents. The motion was then discussed, with the **Resolution to support the motion carried by majority vote (6-2).**
