2.0 MINUTES OF THE LAST MEETINGS: -

The RFO reported that the annual salary increase, based on NJC had been applied and backdated to April as per normal practise.

The RFO asked the Council if they were happy to pay back the pension overpayments paid in error by the previous RFO. Currently trying to get the overpayments back from ESCC. **This was agreed**.

5.0 COMMUNITY Activities and reports.

5.1 District and County Councillors reports

Councillor Killeen reported that the new RDC planning system was up and running on the website. Councillor Barnes reported on the current position re Devolution. The election of the Mayor is due to take place in May 2026 with May 2027 outlined as the start date for the new unitary authority. Councillor Kirby-Green gave her report. Noted that around March 2026 we would hear from central government what was going to happen re devolution and East Sussex.

5.2 <u>Neighbourhood Plan, progress report from steering group representatives</u>

Councillor French gave the report and reported that everything has now been submitted to RDC. Clerk to contact re referendum date.

5.3 <u>Dark Sky Certification Initiative for the South East, motion to support</u>

A presentation was made prior to the meeting re Wild about Dark skies.

Councillor Brown noted that we already had a policy to support this but would like more info before taking further action. To be put on the next agenda.

5.4 Clerk's report

The Clerk gave her report.

Noted that an expression of interest has been submitted to RDC re freehold of Stage Field and the Car park behind the village hall. More info to be obtained from Joe Powell with a meeting to discuss whether to proceed with the car park booked for the 16th October at 7.00pm in the hall.

5.5 Parish Correspondence and local resident issues

Clerk has emailed to councillors upon receipt.

i) Dangerous dogs issue

Reports of two serious dog attacks on livestock in the village, Whilst the first attack was unwitnessed the second was seen and recorded on CCTV but Sussex Police took a month to visit the victims of the second attack and as yet no action taken.

Clerk to contact Katy Bourne the PCC re the Council's concerns over lack of action.

ii) Inconsiderate parking issue - reports rec'd and on Facebook re inconsiderate parking in the village with pedestrians unable to use pavements due to parked cars and hence forced into the road. Councillor Brown and the clerk have reported this to Sussex Police and there appears to be some improvement in the situation with the police being more vigilant.

5.6 Urgent issues requiring attention

Concern expressed re the 24/7 traffic lights being in place on the A21 for 6 weeks outside Ashdene for road improvements and the continuing night closures for tree works.

7.0 PLAYING & STAGE FIELDS

The Cricket Club have reported increased mole activity in Drewetts Field and have asked the Council to action. **This was agreed**. Clerk to contact contractor.

7.1 <u>Stage field, fencing off dangerous depression/hole in field.</u>

Chair reported large hole/depression in Stage Field when mowing. It was agreed that the chair would put up a temporary rope barrier and the site monitored.

Unanimously supported.

7.2 Community Orchard update and finishing of planned works.

Councillor Brown updated the Council re the deer fencing which has arrived and one sample tree fenced off. Main issue at the current time is that the ground is too hard to get stakes in so will need to wait for some rain to soften the ground before further action can be taken.
