RR/2026/0259/FULL - BOARSNEY FARM, The Stage, Salehurst Parish, TN32 5SR. Part demolition and conversion of agricultural buildings to create 9no. residential dwellings with associated cycle/bin stores, parking, landscaping and amended vehicular access. **Not supported.**
