We want as many people as possible to be able to use this website.

- block distractions on screen with a tinted mask
- enlarge text and read it aloud
- remove clutter and display only the main text
- customise options to suit your individual needs or preferences

How we tested this website

As Rother District Council own the website they conduct the checks and according to their accessibility statement "Our website is checked by [SiteImprove](#) for Level A, AA and AAA standards of the WCAG 2.1. We continue to monitor issues that arise using their live report for our website. We aim to fix them as soon as we are able to.

We also subscribe to [Socitm Better Connected](#). They use [Silktide](#) to test local authority sites for accessibility according to [The EU Directive on accessibility of public websites and mobile applications](#). Our results are published on the Socitm Better Connected website."
