We note that the smaller authority did not comply with Regulation 15 of the Accounts and Audit Regulations 2015 as it failed to make proper provision during the year 2016/17 for the exercise of public rights, since the approval date (29/6/16) was after the start of the period for the exercise of public rights (6/6/16).
