LOCAL AUTHORITY ACCOUNTS: A SUMMARY OF YOUR RIGHTS

Please note that this summary applies to all relevant smaller authorities, including parish meetings where there is no parish council.

The basic position

The [Local Audit and Accountability Act 2014](#) (the Act) governs the work of auditors appointed to smaller authorities. This summary explains the provisions contained in Sections 26 and 27 of the Act. The Act and the [Accounts and Audit Regulations 2015](#) also cover the duties, responsibilities and rights of smaller authorities, other organisations and the public concerning the accounts being audited.

As a local elector, or an interested person, you have certain legal rights in respect of the accounting records of smaller authorities. As an interested person you can inspect accounting records and related documents. If you are a local government elector for the area to which the accounts relate you can also ask questions about the accounts and object to them. You do not have to pay directly for exercising your rights. However, any resulting costs incurred by the smaller authority form part of its running costs. Therefore, indirectly, local residents pay for the cost of you exercising your rights through their council tax.

The right to inspect the accounting records

Any interested person can inspect the accounting records, which includes but is not limited to local electors. You can inspect the accounting records for the financial year to which the audit relates and all books, deeds, contracts, bills, vouchers, receipts and other documents relating to those records. You can copy all, or part, of these records or documents. Your inspection must be about the accounts, or relate to an item in the accounts. You cannot, for example, inspect or copy documents unrelated to the accounts, or that include personal information (Section 26 (6) – (10) of the Act explains what is meant by personal information). You cannot inspect information which is protected by commercial confidentiality. This is information which would prejudice commercial confidentiality if it was released to the public and there is not, set against this, a very strong reason in the public interest why it should nevertheless be disclosed.

When smaller authorities have finished preparing accounts for the financial year and approved them, they must publish them (including on a website). There must be a 30 working day period, called the 'period for the exercise of public rights', during which you can exercise your statutory right to inspect the accounting records. Smaller authorities must tell the public, including advertising this on their website, that the accounting records and related documents are available to inspect. By arrangement you will then have 30 working days to inspect and make copies of the accounting records. You may have to pay a copying charge. The 30 working day period must include a common period of inspection during which all smaller authorities' accounting records are available to inspect. This will be 1-12 July 2024 for 2023/24 accounts. The advertisement must set out the dates of the period for the exercise of public rights, how you can communicate to the smaller authority that you wish to inspect the accounting records and related documents, the name and address of the auditor, and the relevant legislation that governs the inspection of accounts and objections.

The right to ask the auditor questions about the accounting records

You should first ask your smaller authority about the accounting records, since they hold all the details. If you are a local elector, your right to ask questions of the external auditor is enshrined in law. However, while the auditor will answer your questions where possible, they are not always obliged to do so. For example, the question might be better answered by another organisation, require investigation beyond the auditor's remit, or involve disproportionate cost (which is borne by the local taxpayer). Give your smaller authority the opportunity first to explain anything in the accounting records that you are unsure about. If you are not satisfied with their explanation, you can question the external auditor about the accounting records.

The law limits the time available for you formally to ask questions. This must be done in the period for the exercise of public rights, so let the external auditor know your concern as soon as possible. The advertisement or notice that tells you the accounting records are available to inspect will also give the period for the exercise of public rights during which you may ask the auditor questions, which here



UDIMORE PARISH COUNCIL Internal Audit Report 2023-24

Introduction

In accordance with the Internal Audit Plan, Controls and Procedures have been tested, with Fraud and Risk Issues reviewed. The tests were to the standards and practices defined in the Governance and Accountability for Smaller Authorities 2023 and meet the needs of the Council. I confirm that I do not have any role within the Council and have carried out my duties without bias.

The audit was completed on 22nd May 2024 at the Burwash Parish office. The report below highlights the findings of the audit with reference to the Internal Control Objectives and Governance Statements in the Annual Return.

Update on issued raised in the 2022-23 Internal Audit.

Appropriate Accounting Records.

Bank reconciliations. Recommend that a Councillor also initials the bank reconciliations and statement. Per financial reg 2.2. **Completed**

Expenditure Approval. Recommended that a Cllr also initials the approved invoice at the time of approval. **Completed**

Financial Regulations, documentation and approvals.

Bank Mandates. Mandates are now current with on line banking but Cllrs are not logging into the system. The Clerk is entering and approving on line payments. **Partly Completed**

– On line payments with 2 signatories is now live but not yet being used.

Budgeting & Precept

Reporting. Actual expenditure is compared with the budget and any significant variances are explained. **Part completed.** Reserves are monitored during the year but not formally considered when setting the budget.

Internal Audit Report 2023-24

A. Appropriate Accounting Records.

- A.1 The financial records are maintained in an XL cash book. The format and financial data is adequate for the Council's needs.
- A.2 VAT is properly accounted for. Reclaims are up to date as at 31-3-24.
- A.3 Financial reports are presented to Council. The Year end reports agree to the financial records and to the 2023-24 AGAR. Noted that expenditure funded from reserves was not included on all spend vs budget reports during the year. This should be included.
- A.4 Bank reconciliations are prepared routinely and are subject to the scrutiny of members. This is registered in the minutes and the reconciliation signed by a Councillor..
- A.5 Expenditure Approval. A sample of payments confirmed the Financial regs were complied with, invoices approved by the Council with and audit trail through the financial records. A Cllr also initials the approved invoice at the time of approval.

B. Financial Regulations, documentation and approvals.

- B.1 Fin Regs & SO were re adopted May 2023 and May 2024.
- B.2 The Agendas & Minutes were posted on the Councils website.
- B.3 Bank Mandates. Mandates are now current with on line banking live but as at May 2024 Cllrs are not active on the system. The Clerk continues to enter and approve on line payments. **The Clerk is aware and will rectify this as soon as possible but this process is not aligned with the financial regulations and does present a risk with the Clerk able input and approve on line payments.**

J. Accounting Statements.

- J.1 The accounts are maintained on a Receipts and Payments basis and the reports agree to the cash book.
- J.2 Reserves – Total reserves are £13.4K General reserves are £4.8K which the Council considers adequate. Higher general reserve levels would be acceptable using Governance and Accountability guides. Earmarked reserves total £8.6K.

K. Limited Assurance Review Exemption.

The Council did correctly exempt itself in 2022-23 and did post the exemption on its website but the values of receipts and payments on the form published did not agree to the financial records.

L. Transparency code.

The Council did publish the data required for 2022-23 in 2023-24 except for a list of payments over £100 which was not published.

M. Exercise of Public Rights 2022-23.

The Council did comply with the audit regulations for publication.

N. Publication of AGAR documents for 2022-23

The Council did publish the correct AGAR forms for 2022-23 on its website.

O. Trust Funds. The Council has confirmed that does not manage any trusts.

It is noted that the figures have been produced by the Clerk in accordance with the requirements and all supporting documents have been produced for the Internal Auditor. The Clerk's co-operation aided considerably the work of this internal audit. Thank you.


